This declaration, including data collection and the modeled foreground system including results, represents the production from a single producer and a single production site. The production site is located at Viby J in Denmark. The end-of-life represents disposal in Denmark. Background data are based on Ecoinvent 3.8 database and are less than 10 years old. Generally, the used background datasets are of high quality, and the majority of the datasets are only a couple of years old.

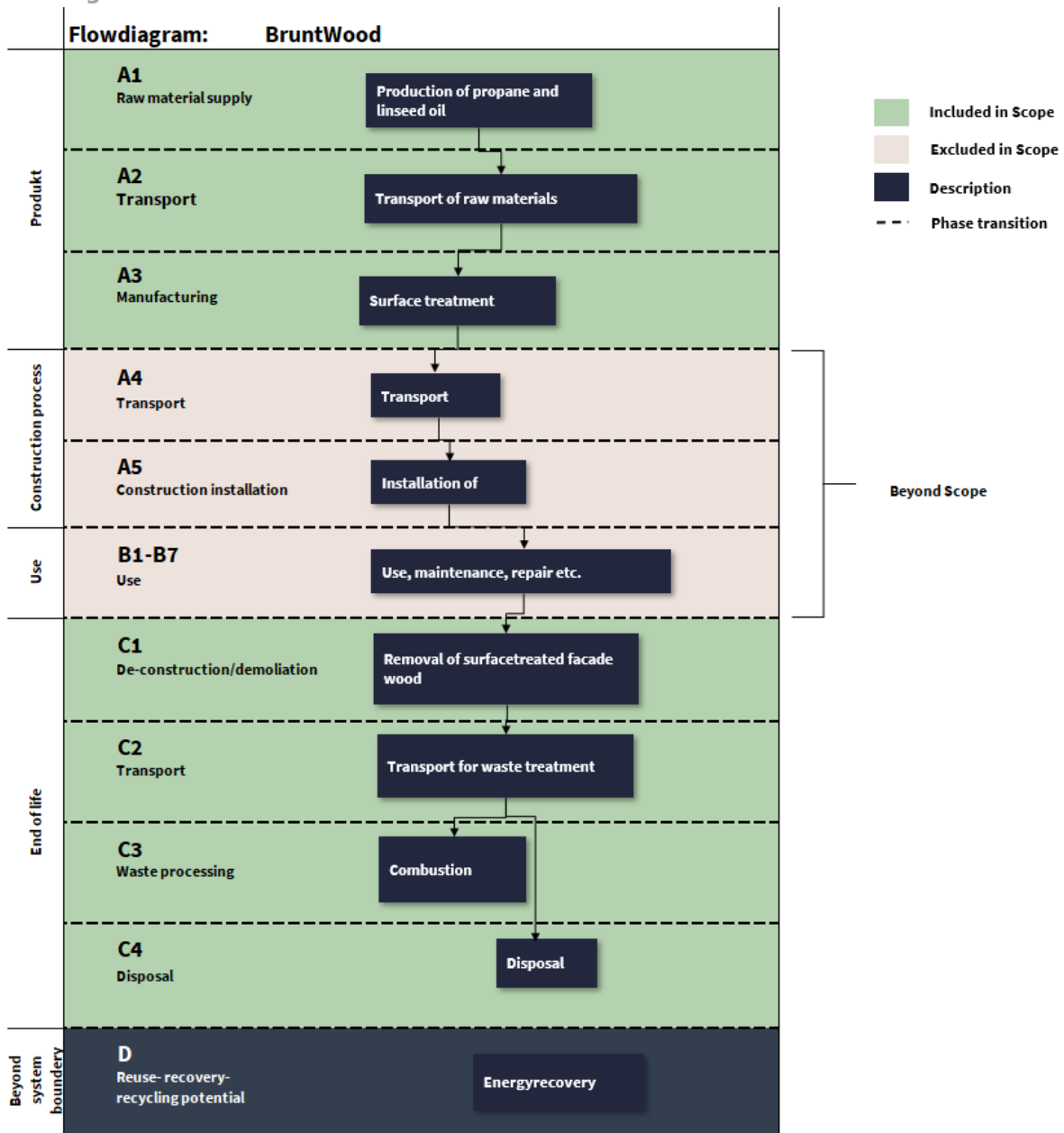

System boundary

This EPD is based on a cradle-to-gate LCA, in which 100 weight-% has been accounted for.

The general rules for the exclusion of inputs and outputs follows the requirements in EN 15804, 6.3.5, where the total of neglected input flows per module shall be a maximum of 5 % of energy usage and mass and 1 % of energy usage and mass for unit processes.

Product stage (A1-A3) includes:

A1 – Extraction and processing of raw materials

A2 – Transport to the production site

A3 – Manufacturing processes

The product stage comprises the acquisition of all raw materials, products and energy, transport to the production site, packaging and waste processing up to the “end-of-waste” state or final disposal. The LCA results are declared in aggregated form for the product stage, which means, that the sub-modules A1, A2 and A3 are declared as one module A1-A3.

End of Life (C1-C4) includes:

End-of-life includes a Danish scenario for waste processing of oiled wood. According to the Danish Environment Agency, oiled wood is treated as combustible waste, which means that the material is incinerated as waste.

C1 – Deconstruction demolition

C2 – Transport to waste processing

C3 – Waste processing

C4 – Disposal

The surface treatment has no influence on the deconstruction or demolition of the surface treated wood.

As this EPD only covers the surface treatment of the wood, the wood isn't included in the end-of-life state. Only the remaining linseed oil in the surface treated wood is included in the waste processing.

Re-use, recovery and recycling potential (D) includes:

As the materials gets incinerated, electricity and heat will be produced, which replaces electricity in the Danish grid mix, and heat produced by natural gas.
